HB 4083 - Local Government Sanctuary Policy Prohibition Act

Bill Summary:

House Bill prohibits local governments from adopting or enforcing a policy that restricts officials or police from communicating or cooperating with appropriate federal officials concerning the status of illegal aliens. The state Attorney General would have to sue if a resident filed a complaint, and local officials who enacted the policy would be liable for fines up to \$7,500.

Bill Summary:

House Bill 4090 prohibits counties from adopting or enforcing a policy that restricts officials or police from communicating or cooperating with appropriate federal officials concerning the status of illegal aliens. The state Attorney General would have to sue if a resident filed a complaint, and courts would have to issue an injunction on enforcement, order repeal, and award damages and costs to a party challenging the county law.

The state Attorney General would have to sue if a resident filed a complaint, and local officials who enacted the policy would be liable for fines up to \$7,500.

It would disqualify counties from receiving reimbursement under the County Jail Reimbursement Program if they enact or

enforce any law, ordinance, policy, or rule that limits or prohibits a peace officer or local official, officer, or employee from communicating or cooperating with appropriate federal officials concerning the immigration status of an individual in the state.

House Bill 4988 prohibits school districts from prohibiting a staff members from communicating or cooperating with appropriate federal officials concerning the immigration status of an individual in this state, or rescinding it if they already have such a policy, subject lawsuits and civil fines of up to \$7,500 for failing to do so.

Bill Summary: House Bill 4679 prevents individuals from receiving housing loans made under the Michigan State Housing Development Authority, unless the individual is a United States Citizen or a Lawful Permanent Resident ("LPR" or "green card holder").
