House Bill 4726 (2019)	Standards for responding to federal immigration holds act	This bill would prohibit a law enforcement official from continuing to detain an individual after that individual becomes eligible for release from custody on the basis of the immigration hold absent a judicial determination that probable cause exists to believe that the individual committed a crime. The bills eliminate the "legal presence" requirement for proving Michigan residency and they would specify types of documentation allowable for proving Michigan residency and identity for the new category of documents.
